## PERMIT TO APPROPRIATE THE PUBLIC WATERS

63610 This is to certify that I have examined APPLICATION 63610 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following This is to certify that I have examined APPLICATION limitations and conditions

This permit is issued to Marvin R. Manes of Route I, Box 1985, Bandon, Oregon 97411, phone 347-3032, for the use of the waters of China Creek, tributary of Bradley Lake.

for the PURPOSE of irrigation, flood harvesting and temperature control of cranberries; being 0.03 cubic foot per second for irrigation, 0.07 cfs for flood harvesting and 0.20 cfs for temperature control provided the total quantity diverted shall not exceed 0.20 cfs that the PRIORITY OF THE RIGHT dates from June 9, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.20 cfs.

The POINT OF DIVERSION is to be LOCATED: 2,600 feet South and 1,760 feet West from the Northeast Corner of Section 18, being within the SW 1/4 NE 1/4 of Section 18, Township 29 South, Range 14 West, WM, in the County of Coos.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 29 South, Range 14 West, WM Section 18 NW 1/4 NE 1/4

1.3 acres irrigation. temperature control (both heat and frost) and flood harvest of cranberries

If for irrigation, this appropriation shall be limited to 1/40 of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before April 29, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19

Complete application of the water to the proposed use shall be made on or before October 1, 19
