PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63829 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Stanley and Annie Bolin of Star Route, Spray, Oregon 97874, for the use of the waters of John Day River, tributary of Columbia River.

for the PURPOSE of $\,$ irrigation and stock water; being 0.25 cubic foot per second for irrigation and 0.005 cfs for stock water

that the PRIORITY OF THE RIGHT dates from August 6, 1982 for 0.25 cfs and February 3, 1983 for 0.005 cfs

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.255 cfs.

The POINT OF DIVERSION is to be LOCATED. 670 feet North and 1,720 feet East from the W 1/4 Corner of Section 10, being within the SE 1/4 NW 1/4 of Section 10, Township 9 South, Range 23 East, WM, in the County of Wheeler.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 9 South, Range 23 East, WM Section 10 NW 1/4 NW 1/4 2.2 acres and stock

SW 1/4 NW 1/4 1.0 acre and stock

SE 1/4 NW 1/4 6.8 acres and stock

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before reasonable diligence and be completed on or before October 1, 19

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 Exercised to Oct. 1, 1986
