## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64420** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Robert G. McKenzie, Jr., PO Box 187, Port Orford, Oregon, 97465, phone 332-3384**, for the use of the waters of two unnamed streams and two reservoirs to be constructed under Application R-64419, Permit R-8604; being 4.95 cubic foot per second from \* **75750** for the PURPOSE of irrigation, temperature control and flood harvesting; being 0.82 cfs from Unnamed Stream 1 and 0.28 cfs from Unnamed Stream 2 for irrigation, and 4.95 cfs from Unnamed Stream 1 and 1.65 cfs from Unnamed Stream 2 for temperature control and \*\* that the PRIORITY OF THE RIGHT dates from **October 7, 1982**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **6.6 cfs.**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 460 feet East of Northwest Corner of NE 1/4 SW 1/4 of Section 29, Diversion 2 - 180 feet East from said Northwest Corner of NE 1/4 SW 1/4 of Section 29, being within the NE 1/4 SW 1/4 of Sections 29, Township 31 South, Range 15 West, WM, in the County of Curry.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- \* Unnamed Stream 1 and 1.65 from Unnamed Stream 2.
- \*\* 0.64 cfs from Unnamed Stream 1 and 0.56 cfs from Unnamed Stream 2 for flood harvesting, provided the total diverted shall not exceed 6.6 cfs.

Actual construction work shall begin on or before **April 29, 1984** and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

If for irrigation, this appropriation shall be limited to  $\frac{1}{40}$  of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to  $\frac{1}{80}$  of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoirs to be constructed under Permit R-8604 and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control (frost protection) on forms furnished.
