PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63760 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to John Harry Jacobson of 7130 Smullen Road, Mt. Hood, Oregon 97041, phone 352-7492, for the use of the waters of an unnamed creek, Yellow Jacket Creek, East Fork Hood River and 4 reservoirs to be constructed under Application R-64548, Permit R-8667, being 0.68* for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from July 12, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.68 cfs

The POINT OF DIVERSION is to be LOCATED: Unnamed Creek - 3280 feet North and 1400 feet East from the SE Corner, Section 4, being within the SE 1/4 NW 1/4, Section 3; Yellow Jacket Creek - 1200 feet South and 1280 feet West from the SE Corner, Section 4, being within the NE 1/4 NE 1/4; Reservoir 1 - 250 feet South and 2750 feet West from the SE Corner, Section 4, being within the NE 1/4 NW 1/4, both Section 9; Reservoir 2 - 750 feet North and 2100 feet West from the**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * cubic foot per second from the unnamed creek with any deficiency to be supplied by East Fork Hood River and Yellow Jacket Creek,
- ** SE Corner, Section 4, being within the SW 1/4 SE 1/4, Section 4; Reservoir 3 - 200 feet North and 1500 feet West from the SE Corner, Section 4, being within the NW 1/4 SE 1/4, Section 4; Reservoir 4 - 2200 feet North and 1000 feet West from the SE Corner, Section 4, being within the NE 1/4 SE 1/4, Section 4; all within Township 1 South, Range 10 East, WM, in the County of Hood River.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoirs to be constructed under Permit R-8667, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before May 31, 1984⁸⁵ and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985. Extended to October 1987. Extended to October 1, 1988. Extended to October 1, 1988.
