## PERMIT TO APPROPRIATE THE PUBLIC WATERS

64543 This is to certify that I have examined APPLICATION 64243 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

irrigation and recreation, being 0.10 cubic foot per second for irrigation and 

that the PRIORITY OF THE RIGHT dates from April 22, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.12 cfs

850 feet North and 50 feet East from the Common Corner of The POINT OF DIVERSION is to be LOCATED. South, Range 4 West, WM, and Sections 5 and 6, Township 26 South, Range 4 West, WM, and Sections 5 and 6, Township 27 South, Range 4 West, WM, being within the SW 1/4 SW 1/4 of Section 32, Township 26 South, Range 4 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 4 West, WM

Section 31 SE 1/4 SE 1/4 Section 32 SW 1/4 SW 1/4 3.0 acres irrigation

5.0 acres irrigation and pond maintenance for

recreation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

May 31, 1984 Actual construction work shall begin on or before , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19  $^{85}$  .

Complete application of the water to the proposed use shall be made on or before October 1, 19  $^{86}$  .
