PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65000** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **William H. and Martha A. Goodman of Route 1, Box 415A, Amity, Oregon 97101, phone 835-5565**, for the use of the waters of an unnamed stream and reservoir constructed under Permit R-1415, tributary of Yamhill River for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **April 8, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.25 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **2200 feet North and 770 feet East from the Southwest Corner of Section 11, being within the NW 1/4 SW 1/4 of Section 11, Township 5 South, Range 4 West, WM, in the County of Yamhill.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 5 South, Range 4 West, WM	Section 10	NE 1/4	SE 1/4	12.0 acres
	Section 11	NW 1/4	SW 1/4	8.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from reservoir constructed under Permit R-1415 and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **May 31, 1984** and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
