## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61049 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jerry Bogh of Route 1, Box 918, Astoria, Oregon 97103, phone 325-4862, for the use of the waters of an unnamed stream, tributary of West Lake

for the PURPOSE of supplemental irrigation, chemical application, temperature control and flood harvesting of cranberries, being 0.15 cubic foot per second for irrigation, 0.15 cfs for chemical application, 0.87 cfs for temperature control and 1.50 cfs for 12 hours per day not to exceed 5.8 \* that the PRIORITY OF THE RIGHT dates from December 4, 1980 for 0.15 cfs for irrigation, 0.87 cfs for temperature control and 0.3 cfs for flood harvesting, and March 30, 1983 for 0.15 cfs for chemical application and 1.2 cfs for flood harvesting

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.5 cfs

The POINT OF DIVERSION is to be LOCATED: 1750 feet North and 1720 feet West from the SE Corner of Section 27, being within the NW 1/4 SE 1/4 of Section 27, Township 7 North, Range 10 West, WM, in the County of Clatsop.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* acre-feet per season for flood harvesting, provided the total quantity diverted shall not exceed 1.5 cfs

If for irrigation, this appropriation shall be limited to  $\frac{1}{40}$  of one cubic foot per second of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, for cranberries. If for the irrigation of any other crop, this appropriation shall be limited to  $\frac{1}{80}$  of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished.

Actual construction work shall begin on or before June 13, 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
