## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 63326 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Cameron Cliff of PO Box 97, LaPine, Oregon 97739, for the use of the waters of Island Branch-Silver Creek and Thompson Valley Reservoir constructed under Permit R-4461.

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from February 23, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 15.38 cubic feet per second of water

The POINT OF DIVERSION is to be LOCATED: 1550 feet South and 1770 feet West from the NE Corner of Section 15, WM, being within the SW 1/4 NE 1/4 of Section 15, Township 28 South, Range 14 East, WM, in the County of Lake. Thompson Valley Dam is located in the SE 1/4 SW 1/4 of Section 17, Township 30 South, Range 14 East, WM

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Actual construction work shall begin on or before 3 1984, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19  $^{86}$  .
