## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64896** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Charles R. Maurer of 1695 North River Road, Gold Hill, Oregon 97525, phone 855-7704, for the use of the waters of Rogue River.**

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **February 25, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.59 cfs**

The POINT OF DIVERSION is to be LOCATED: **1320 feet North and 1540 feet East from the SW Corner of Section 24, being within the NE 1/4 SW 1/4 of Section 24, Township 36 South, Range 4 West, WM, in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 36 South, Range 4 West, WM	Section 24	NW 1/4	SW 1/4	26.0 acres
		SW 1/4	SW 1/4	17.0 acres
		NE 1/4	SW 1/4	4.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **June 13, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
