and is limited to the amount of water which can be applied to beneficial use and shall not exceed

50 feet North and 375 feet West from the Center Corner of The POINT OF DIVERSION is to be LOCATED: 50 feet North and 375 feet West from the Center Corner of Section 9, being within the SE I/4 NW I/4 of Section 9, Township I North, Range 4 West, WM, in the County of Washington.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for Irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, water shall not be appropriated from direct flow during the period from July 31 through September 15 of each year except for human and livestock consumption, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
