PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64797** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Leo Beach and Mary Beach of 3358 Northwest Taylor Street, Corvallis, Oregon 97330, phone 753-3040, for the use of the waters of Fern Ridge Reservoir constructed under Permit R-1625, tributary Long Tom River** for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **January 28, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **1.08 acre-feet stored water only**

The POINT OF DIVERSION is to be LOCATED: **2903 feet North and 1002 feet West from the Southwest Corner of William Jean DLC 48, being within the NE 1/4 SW 1/4 of Section 20, Township 17 South, Range 5 West, WM, in the County of Lane.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 17 South, Range 5 West, WM Section 20 NE 1/4 SW 1/4 0.5 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to a diversion of not to exceed **2.5 acre-feet per acre** for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 3-07-10-W0474 between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Director, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **July 15, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
