## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61804 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following 61804 limitations and conditions:

This permit is issued to On the Way, Incorporated, by Paul Winters, President of 4500 Alderwood Drive, Coos Bay, Oregon 97420, phone 640-2888, for the use of the waters of 3 unnamed streams and three reservoirs to be constructed under Application R-61803, Permit R-8655, and 4\* for the PURPOSE of domestic use for one family including lawn, noncommercial garden not to exceed one-half acre and garden, irrigation, and stockwater, being 0.0025 cubic foot of water per second from each spring for domestic use for one family including irrigation of not to exceed one-half\*\* that the PRIORITY OF THE RIGHT dates from November 12, 1982

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.29 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 1 - 555 feet South and 170 feet East; 2 - 325 feet South and 400 feet East; Spring 1 - 265 feet South and 10 feet East; Spring 2 - 430 feet South and 10 feet East; Spring 3 - 610 feet South and 560 feet East; Spring 4 - 500 feet South and 800 feet East; Reservoir 1 - 820 feet South and 80 feet East; Reservoir 2 - 160 feet South and 25 feet East; all from the Center 1/4 Corner of Section 18, being within the NW 1/4 SE 1/4 of Section 18,\*\*\*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* unnamed springs, being 0.26 cubic foot per second of water from unnamed Stream 3 and Reservoir 3 with any deficiency n the available supply from unnamed Stream 3 to be made up by diversion from unnamed Stream 1 and Reservoir 1, 0.01 cfs from unnamed Stream 2 and Reservoir 2 and 0.005 cfs from each spring, tributaries of Ross Inlet,

acre lawn and noncommercial garden, 0.0025 cfs from each spring for stock water, and

0.27 cfs for irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, from direct flow and storage from three reservoirs to be constructed under Permit R-8655, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.
