PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64962** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Donald L. Duncan of Route 3, Box 1315, Alsea, Oregon 97324, phone 486-4311** for the use of the waters of **Chilcote Creek, unnamed stream and a spring, being 0.13 cubic foot per second of water from Chilcote Creek, 0.01 cfs from unnamed stream and 0.01 cfs from*** for the PURPOSE of **irrigation, stock water and domestic use for one family, being 0.14 cfs for irrigation (0.13 cfs from Chilcote Creek and 0.01 cfs from the unnamed stream), 0.005 cfs for stockwater and 0.005 cfs for domestic use for one family from spring** that the PRIORITY OF THE RIGHT dates from **March 29, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.15 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Unnamed stream - 1620 feet North and 530 feet East; Spring - 1620 feet North and 1580 feet East; Diversion 1 - 1700 feet North and 1670 feet East; Diversion 2 - 1720 feet North and 2320 feet East, all from the SW Corner of Section 1, being within the NW 1/4 SW 1/4, NE 1/4 SW 1/4 of Section 1, Township 15 South, Range 9 West, WM, in the County of Benton.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* **spring,**

Township 15 South, Range 9 West, WM Section 1 NE 1/4 SW 1/4 11.0 acres irrigation and domestic use for one family and stockwater

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **July 27, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
