## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64964** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Tom and Nancy Vanasche of 3544 Northwest Terrace Drive, Albany, Oregon 97321, phone 926-1112** for the use of the waters of South Santiam River, tributary Santiam River

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **March 29, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.49 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **550 feet South and 1560 feet West from the NE Corner of Section 30, being within the NW 1/4 NE 1/4 of Section 30, Township 10 South, Range 2 West, WM, in the County of Linn.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 10 South, Range 2 West, WM	Section 30	NW 1/4	NE 1/4	17.3 acres
		SW 1/4	NE 1/4	20.0 acres
		NE 1/4	NW 1/4	0.2 acre
		SE 1/4	NW 1/4	1.4 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **July 27, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
