## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64950** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Jay K. Zieba of 8444 Takilma Road, Cave Junction, Oregon 97523, phone 592-4476, for the use of the waters of East Fork Illinois River and a reservoir to be constructed under Application R-65185, Permit R-8800, a tributary of Illinois River, for the PURPOSE of irrigation**

that the PRIORITY OF THE RIGHT dates from **April 12, 1983 for 0.10 cubic foot per second of water and June 9, 1983 for 0.04 cfs**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.14 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **1500 feet North and 440 feet East from the SW Corner of Section 26 being within NW 1/4 SW 1/4 of Section 26; Reservoir - 2200 feet South and 1820 feet East from the NW Corner of Section 26, being within the SE 1/4 NW 1/4 of Section 26, Township 40 South, Range 8 West, WM, in the County of Josephine.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 40 South, Range 8 West, WM Section 26 SE 1/4 NW 1/4 7.12 acres Irrigation**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to **1/80** of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed **2.5** acre-feet per acre from direct flow and storage from the reservoir to be constructed under Permit R-8800.

Actual construction work shall begin on or before **August 25, 1984** and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
