PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64952** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Arnold H. and Marian T. Anderson of PO Box 553, Cave Junction, Oregon 97523, phone 592-3782, for the use of the waters of an unnamed stream, springs, West Fork Illinois River and two reservoirs to be constructed under Application R-64951, Permit R-8663,*** for the PURPOSE of **recreation and irrigation; being 0.01 cfs for recreation and 0.18 cfs for irrigation**

that the PRIORITY OF THE RIGHT dates from **March 24, 1983 for 0.18 cfs, May 6, 1983 for 0.005 cfs and May 18, 1983 for 0.005 cfs**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.19 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Pond 1 - 410 feet North and 3840 feet West, Pond 2 - 510 feet North and 3730 feet West, both from the SE Corner, being within the SE 1/4 SW 1/4 of Section 32, Township 39 South, Range 8 West, WM, in the County of Josephine.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

*** being 0.095 cubic foot per second from unnamed stream and 0.095 cfs from springs with any deficiency in the available supply from the unnamed stream and springs to be made up by diversion from the West Fork Illinois River, provided the total diverted shall not exceed 0.19 cfs,**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/50 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre from direct flow and storage from the reservoir to be constructed under Permit R-8663.

Actual construction work shall begin on or before **August 25, 1984** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** .
