PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64846** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **John G. Wongler of Route 3, Box 850, Prineville, Oregon 97754, phone 447-4166, for the use of the waters of Crooked River via Peoples Irrigation Ditch, tributary of Deschutes River**

for the PURPOSE of **Irrigation**

that the PRIORITY OF THE RIGHT dates from **February 17, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.88 cfs**

The POINT OF DIVERSION is to be LOCATED: **Peoples Ditch - 744.2 feet South and 321 feet East from the Northwest Corner of SW 1/4, Section 8 (W 1/4 Corner); Dam and Works - 744.25 feet South and 410 feet East from the Northwest Corner of SW 1/4, Section 8, both being within the NW 1/4 SW 1/4 of Section 8, Township 15 South, Range 16 East, WM; People's Ditch-Pump and Pipeline - 40 feet North and 545 feet East from Southwest Corner of Section 26 being within the SW 1/4 ***

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* **SW 1/4 of Section 26, Township 14 South, Range 16 East, WM, in the County of Crook.**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **September 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
