PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **64848** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **John Hannah of 12228 NE 97th, Kirkland, WA 98033, phone 206-822-4505, for the use of the waters of South Fork Umpqua River**

for the PURPOSE of **irrigation and stockwater, being 0.625 cubic foot per second for irrigation and 0.005 cfs for stockwater**

that the PRIORITY OF THE RIGHT dates from **February 18, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.63 cfs**

The POINT OF DIVERSION is to be LOCATED: **430 feet North and 730 feet West from the Southeast Corner of Section 15, being within the SE 1/4 SE 1/4 of Section 15, Township 28 South, Range 6 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 28 South, Range 6 West, WM	Section 15	NE 1/4	SE 1/4	23.0 acres and stock water
		NW 1/4	SE 1/4	0.4 acre
		SE 1/4	SE 1/4	26.6 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **September 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
