PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65210 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jack E. Mahana of Route 2, Box 81F, Kings Valley Route, Monmouth, Oregon 97361, phone 929-2296, for the use of the waters of Luckiamute River

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from June 20, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.15 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: 2170 feet North and 2580 feet East from the Southwest Corner of Chambers DLC 46; being within the NW 1/4 SW 1/4 of Section 16, Township 10 South, Range 6 West, WM, in the County of Benton

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 10 South, Range 6 West, WM Section 16 NW 1/4 SW 1/4 0.2 acre Section 17 SE 1/4 NE 1/4 8.1 acres NE 1/4 SE 1/4 3.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before $\frac{\text{September 27, }1984}{\text{Months}}$, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 $\frac{85}{100}$.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
