PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65234** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Russell Dean Hendron of 5965 Little River Road, Glide, Oregon 97443, phone 496-3889**, for the use of the waters of an unnamed stream and Little River, being 0.005 cubic foot per second from the unnamed stream and 0.019 cfs from Little River, tributaries of North * for the PURPOSE of **irrigation and domestic use for one family, being 0.019 cfs from Little River for irrigation and 0.005 cfs from unnamed stream for domestic use for one family**

that the PRIORITY OF THE RIGHT dates from **June 27, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.024 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Unnamed Stream - 700 feet North and 1250 feet West; Little River 920 feet North and 1020 feet West, both from the Southeast Corner of Section 34; being within the SE 1/4 SE 1/4 of Section 34, Township 26 South, Range 3 West, WM, In the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* **Umpqua River**

Township 26 South, Range 3 West, WM Section 34 SE 1/4 SE 1/4 1.5 acre and Domestic use for one family

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to **1/80** of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed **2.5** acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **September 27, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19**85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19**86**.
