## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **60890** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **City of Phoenix, City Hall, 510 West First Street, Phoenix, Oregon 97535, phone 535-1955, for the use of the waters of Rogue River and 400.0 acre-feet from Lost Creek Reservoir, constructed under Permit R-8142, to be stored under Application R-60889, \*** for the PURPOSE of **municipal**

that the PRIORITY OF THE RIGHT dates from **October 9, 1980**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **5.0 cubic feet per second**

The POINT OF DIVERSION is to be LOCATED: **South 25 degrees 27 minutes 48 seconds East 4408.38 feet from the Northeast Corner of DLC 42, being within the NE 1/4 NE 1/4 of Section 13, Township 36 South, Range 2 West, WM; in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:
