## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65280 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Crimson West Farms, Incorporated of Route 3, Box 118, McMinnville, Oregon 97123, phone 835-2582, for the use of the waters of South Yamhill River, tributary Willamette River,

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from July 8, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.97 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: 2000 feet North and 1560 feet East from the Southwest Corner of Section 26; being within the NE 1/4 SW 1/4 of Section 26; Diversion Point 2 is located 350 feet South and 1140 feet East from the Northwest Corner of Section 35, being within the NW 1/4 NW 1/4 of Section 35; Diversion Point 3 is located 1300 feet North and 1600 feet East from the Southwest Corner of Section 34; being within the SE 1/4 SW 1/4, Section 34 all in \*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 5 South, Range 5 West, WM; in the County of Yamhill.
