PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65717** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Robert E. and April E.A.L. Wood of Star Route, Box 157, Birkenfeld, Oregon 97016, phone 755-9326, for the use of the waters of Nehalem River**

for the PURPOSE of **irrigation and domestic use for one family, being 0.06 cubic foot per second of water for irrigation and 0.005 cfs for domestic use**

that the PRIORITY OF THE RIGHT dates from **August 26, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.065 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **350 feet North and 300 feet East from the Southwest Corner of Section 27, being within the SW 1/4 SW 1/4 of Section 27, Township 6 North, Range 6 West, WM; in the County of Clatsop.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 6 North, Range 6 West, WM	Section 27 SW 1/4	SW 1/4	4.2 acres and domestic
	Section 28 SE 1/4	SE 1/4	0.6 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **October 11, 1984** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** .
