PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 64769 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Amfac Nurseries of Oregon, 3150 Southeast Minter Bridge Road, Hillsboro, Oregon 97123, phone 640-4633, for the use of the waters of Forest Grove Sewage Treatment Plant and a reservoir to be constructed under Application R-58694, Permit R-8808, for the PURPOSE of irrigation and supplemental irrigation

that the PRIORITY OF THE RIGHT dates from January 19, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.67 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: Plant 1 - 1200 feet South from the Southeast Corner of Henry Clark DLC 37, being within the SW 1/4 SW 1/4 of Section 5, Township 1 South, Range 3 West, WM; Reservoir 2 - 100 feet North and 625 feet West from the Southwest Corner of T.G. Naylor DLC 37, being within the NE 1/4 SE 1/4 of Section 2, Township 1 South, Range 4 West, in the County of Washington.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before October 28, 1984 reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
