PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65173 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to George A. Walker, George R. Walker and Lula Fay Walker of Route I, Box 1566, La Grande, Oregon 97850, phone 963-5667, for the use of the waters of Smith Creek and a reservoir to be constructed under Application R-65015, Permit R-8810, for the PURPOSE of

supplemental irrigation and fish culture, being 0.2 acre-foot stored water only from the reservoir for supplemental irrigation and 0.01 cubic foot of water per second from Smith Creek for fish culture.
that the PRIORITY OF THE RIGHT dates from
June 6, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic foot per

The POINT OF DIVERSION is to be LOCATED: 760 feet South and 180 feet East from the Northwest Corner of the NE 1/4 SE 1/4; Reservoir - 414 feet South and 192 feet West from the E 1/4 Corner of Section 33, being within the NE 1/4 SE 1/4 of Section 33, Township 1 South, Range 38 West, WM, in the County of Union.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

fish culture supplemental irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before October 28, 1984 reasonable diligence and be completed on or before October 1, 19 85 .
