PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65034** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Harvey C. Rose of Route 3, Box 295B, Hillsboro, Oregon 97123, phone 647-2694, for the use of the waters of an unnamed stream, tributary of McKay Creek,**

for the PURPOSE of **irrigation, stockwater and domestic use for one family, being 0.03 cubic foot per second for irrigation, 0.005 cfs for stockwater, and 0.005 cfs for domestic use for one family**

that the PRIORITY OF THE RIGHT dates from **April 21, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.048 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **1305 feet South and 160 feet West from the N 1/4 Corner of Section 19, being within the SE 1/4 NW 1/4 of Section 19, Township 2 North, Range 2 West, WM, in the County of Washington.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 2 North, Range 2 West, WM Section 19 SE 1/4 NW 1/4 3.0 acres domestic use for one family and stock water

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further water shall not be appropriated (from direct flow) during the period from July 31 through September 15 of each year (except for human and livestock consumption) reservoir = each year, except for stored water, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **November 17, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
