PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65136** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Bert and Emelyn Christensen of 337 Northwest 23rd Street, Corvallis, Oregon 97330, phone 753-3788, for the use of the waters of Fern Ridge Reservoir constructed under Permit R-1625,** for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **May 20, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.16 acre-foot** of **stored water only**

The POINT OF DIVERSION is to be LOCATED: **465 feet South and 1380 feet West from the C 1/4 Corner of Section 20, being within the NW 1/4 SW 1/4 of Section 20, Township 17 South, Range 5 West, WM, in the County of Lane.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 17 South, Range 5 West, WM Section 20 NE 1/4 SW 1/4 0.16 acre

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited a diversion of not to exceed **2.5 acre-feet per acre** for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of Contract 3-07-10-W0481 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director,

Actual construction work shall begin on or before **November 17, 1984** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** .
