## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65157 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Wayne M. Scott of Route 1, Box 24, Cove, Oregon 97824, phone 568-4808, for the use of the waters of an unnamed stream, a tributary of Mill Creek,**

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **May 27, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.21 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **270 feet North and 425 feet East from the Northwest Corner of the NE 1/4 SE 1/4 of Section 22, being within the SE 1/4 NE 1/4 of Section 22, Township 3 South, Range 40 West, WM, in the County of Union.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 3 South, Range 40 East, WM Section 23 SW 1/4 NW 1/4 3.5 acres  
NW 1/4 SW 1/4 13.5 acres**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **November 22, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
