PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65239 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Mark C. and Sharon L. Vilsmeyer of PO Box 96, Brogan, Oregon 97903, phone 473-2656, for the use of the waters of Canyon Creek, a tributary of Snake River,

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from May 13, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.75 cubic foot per second of water

The POINT OF DIVERSION is to be LOCATED: 440 feet South and 200 feet West from the Northeast Corner of the SW 1/4 SE 1/4 of Section 16, being within the SW 1/4 SE 1/4 of Section 16, Township 15 South, Range 42 East, WM, in the County of Malheur.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 15 South, Range 42 East, WM Section 16 SW 1/4 SW 1/4 6.0 acres SE 1/4 SW 1/4 5.0 acres SW 1/4 SE 1/4 10.0 acres SE 1/4 SE 1/4 7.0 acres Section 21 NW 1/4 NW 1/4 2.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **December 2, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
