PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65268 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following

This permit is issued to Billy Ray Bowlin of Route 4, Box 1122A, Roseburg, Oregon 97470, phone 679-6654, for the use of the waters of Lookingglass Creek, a tributary of South Umpqua River,

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from July 5, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.125 cubic foot per

The POINT OF DIVERSION is to be LOCATED: 550 feet North and 200 feet West from the Southeast Corner of Section 33, being within the SE 1/4 SE 1/4 of Section 33, Township 27 South, Range 7 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 27 South, Range 7 West, WM

Section 33

SE 1/4

SE 1/4 10.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before December 2, 1984 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85. Extended to October 1, 1988

Complete application of the water to the proposed use shall be made on or before October 1, 19 86. Extended to October 1, 1986
