PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65252** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Ivan and Marjorie Porfily** of Route 1, Box 131, Mt. Vernon, Oregon 97865, phone 932-4627, for the use of the waters of Riley Creek, a tributary of John Day River,

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **July 1, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.85 cubic foot per second of water**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 890 feet South and 2180 feet East from the Northwest Corner of Section 30, being within the NE 1/4 NW 1/4; Diversion 2 - 1660 feet South and 2070 feet East of the Northwest Corner of Section 30, being within the SE 1/4 NW 1/4; Diversion 3 - 3320 feet South and 1760 feet East of the Northwest Corner of Section 30, being within the NE 1/4 SW 1/4 all of Section 30, Township 13 South, Range 30 East, WM, in the***

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **December 2, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
