PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65260 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Jamey Mazzotta of PO Box 187, Bella Vista, California 96008, for the use of the waters of South Fork John Day River, a tributary of John Day River,

for the PURPOSE of irrigation and supplemental irrigation

that the PRIORITY OF THE RIGHT dates from July 1, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.75 cubic foot per second of water

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 1640 feet South and 420 feet East from the Northwest Corner of Section 18, being within the SW 1/4 NW 1/4 of Section 18; Diversion 2 - 1020 feet South and 1880 feet East from the Northwest Corner of Section 18, being within the NE 1/4 NW 1/4 of Section 18; Diversion 3 - 1800 feet South and 460 feet East from the Northwest Corner of Section 18, being within the SW 1/4 NW 1/4 of 18, all within Township 13* A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* South, Range 27 East, WM, in the County of Grant.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before $\frac{1984}{1}$, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 85.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
