PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65324** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Joann Sandstede, Jean C. Bradley and Donna J. Clough of 135 West Berdine Street, Roseburg, Oregon 97470, phone 672-2409, for the use of the waters of the Clough Gulch, a tributary of South Umpqua River,** for the PURPOSE of **domestic use for one family including the irrigation of not to exceed one-half acre lawn and noncommercial garden and stockwater, being 0.01 cubic foot per second for domestic use for one family including the irrigation of not to exceed one-half acre lawn and\*** that the PRIORITY OF THE RIGHT dates from **July 19, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.02 cfs**

The POINT OF DIVERSION is to be LOCATED: **4880 feet North and 1730 feet West from the Southeast Corner of Section 13, being within the NW 1/4 NE 1/4 of Section 13, Township 30 South, Range 5 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* noncommercial garden and 0.01 cfs for stockwater

Actual construction work shall begin on or before **December 20, 1984** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** .
