PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65332** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **John Wetle of 616 Vicksburg Avenue, Bend, Oregon 97701, phone 382-0380,** for the use of the waters of **Tooze Spring or Metolius River, a tributary of Deschutes; being 0.01 cubic foot per second from either source provided the total quantity diverted shall not exceed*** for the PURPOSE of **domestic use for two families including the irrigation of not to exceed one-half acre lawn and noncommercial garden**

that the PRIORITY OF THE RIGHT dates from **July 21, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.01 cfs**

The POINT OF DIVERSION is to be LOCATED: **Tooze Spring - 80 feet North and 340 feet East from the Northwest Corner of NE 1/4 NE 1/4 of Section 3, Township 13 South, Range 9 East, WM, being within SE 1/4 SE 1/4 of Section 34, Township 12 South, Range 9 East, WM; Metolius River - 170 feet South and 530 feet East from the Northwest Corner of NE 1/4 NE 1/4 of Section 3, being within the NE 1/4 NE 1/4 of Section 3, Township 13 South, Range 9 East WM, in the County of****
A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 13 South, Range 9 East, WM Section 3 NE 1/4 NE 1/4 Domestic use for two families including the irrigation of not to exceed one-half acre lawn and noncommercial garden

Actual construction work shall begin on or before **December 20, 1984** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** .
