PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65334** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Steve McKern of PO Box 922, Mt. Vernon, Oregon 97865, phone 932-4911, for the use of the waters of John Day River, a tributary of Columbia River,**

for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **July 22, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.38 cfs**

The POINT OF DIVERSION is to be LOCATED: **80 feet North and 1310 feet West from the E 1/4 Corner of Section 29, being within the SE 1/4 NE 1/4 of Section 29, Township 13 South, Range 30 East, WM, in the County of Grant.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 13 South, Range 30 East, WM Section 30 SE 1/4 NE 1/4 15.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **December 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** Extended to October 1987

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** Extended to October 1987
