PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65350** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Steven R. Bryant of 1671 Country Club Road, Hood River, Oregon 97031, phone 386-6938, for the use of the waters of Rowena Creek, a tributary of Columbia River,**

for the PURPOSE of **irrigation and stock, being 0.19 cubic foot per second for irrigation and 0.005 cfs for stock**

that the PRIORITY OF THE RIGHT dates from **July 25, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.195 cfs**

The POINT OF DIVERSION is to be LOCATED: **440 feet South and 330 feet East from the N 1/4 Corner of Section 16, being within the NW 1/4 NE 1/4 of Section 16, Township 2 North, Range 12 East, WM, in the County of Wasco.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 2 North, Range 12 East, WM Section 16 NE 1/4 NE 1/4 10.0 acres
NW 1/4 NE 1/4 10.0 acres and stock**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **December 20, 1984**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
