PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65586** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Fred and June Hanson of Route 1, Box 460, John Day, Oregon 97845, phone 932-4681, for the use of the waters of an unnamed stream and Badger Creek, being 0.03 cubic foot per second of water from the unnamed stream and 0.82 cfs from Badger Creek, a tributary*** for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **August 22, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.85 cfs**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 2660 feet South and 2000 feet West from the Northeast Corner of Section 32, being within the NW 1/4 SE 1/4 of Section 32; Diversion 2 - 280 feet South and 780 feet East from the Northeast Corner of Section 32, being within the NW 1/4 NW 1/4 of Section 33; Diversion 3 - 680 feet North and 700 feet East from the Northeast Corner of Section 32, being within the SW 1/4 SW 1/4 of Section 28 all within Township 12 South,****

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **January 6, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
