PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 65613 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Charles L. Vaughn of PO Box 641, Winston, Oregon 97496, phone 679-5217, for the use of the waters of an unnamed stream and reservoir, a tributary of Lookingglass Creek, to be constructed under Application R-65612, Permit R-8992,

 $_{\rm for\ the\ PURPOSE\ of}$ irrigation and stock water, being 0.53 cubic foot per second for irrigation and 0.01 cfs for stock water

that the PRIORITY OF THE RIGHT dates from August 25, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.54 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 100 feet South and 600 feet East; Diversion 2 - 500 feet South and 650 feet East both from the N I/4 Corner of Section 20, being within the NW I/4 NE I/4 of Section 20, Township 28 South, Range 6 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 from direct flow and storage from reservoir to be constructed under R-8992 provided further that during the period from June 1 through September 30 of each year the waters of Lookingglass Creek and tributaries are classified only for stockwater of less than 5000 gallons per day per appropriation; stored water may be used at any time.

Actual construction work shall begin on or before January 6, 1985 reasonable diligence and be completed on or before October 1, 19 85 .

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
