This is to certify that I have examined APPLICATION 65820 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Fred Cramer of 540 Lomas Road, Jacksonville, Oregon 97530, phone 899-8200, for the use of the waters of a spring and unnamed stream,

for the PURPOSE of **domestic use for one family and irrigation; being 0.005 cubic foot per second from spring for domestic use for one family and 0.056 cfs from unnamed stream for irrigation**

that the PRIORITY OF THE RIGHT dates from **September 1, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.061 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Spring - 1150 feet South and 325 feet West from the W 1/4 Corner of Section 4, being within the NE 1/4 SE 1/4 of Section 5; Unnamed Stream - 750 feet North and 1320 feet East from the W 1/4 Corner of Section 4, being within the SE 1/4 NW 1/4 of Section 4, both within Township 39 South, Range 3 West, WM, in the County of Jackson.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 39 South, Range 3 West, WM Section 4 NE 1/4 NW 1/4 5.0 acres Irrigation and domestic use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **January 9, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 19 85** .

Complete application of the water to the proposed use shall be made on or before **October 1, 19 86** .
