PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **65985** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Ray E. Dempsey and Evelyn Dempsey of 1568 NW Martin, Roseburg, Oregon 97470, phone 672-1207**, for the use of the waters of **Applegate River and Applegate Lake Reservoir, a tributary of Rogue River, to be constructed under Permit 7810**, for the PURPOSE of **domestic use for one family and irrigation, being 0.005 cubic foot per second from Applegate River for domestic use and 0.02 cfs from Applegate River and Applegate Lake Reservoir for irrigation** that the PRIORITY OF THE RIGHT dates from **September 8, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.025 cfs**

The POINT OF DIVERSION is to be LOCATED: **Applegate River - 810 feet North and 610 feet East from the Southwest Corner of Section 5, being within the SW 1/4 SW 1/4 of Section 5, Township 37 South, Range 6 West in the County of Josephine; Applegate Lake Dam is located in the SE 1/4 of Section 25, Township 40 South, Range 4 West, WM.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 37 South, Range 6 West, WM Section 5 SW 1/4 SW 1/4 1.5 acres
SW 1/4 SW 1/4 Domestic use**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.5 and is subject to the terms and conditions of Contract 3-07-10-W0507 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before **January 16, 1985** , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85** . Extended to Oct. 1, 1986

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86** . Extended to October 1987
