PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 66050 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Delmas and Sheryl Raymond of Route 2, Box 701, Prairie City, Oregon 97869, phone 820-3309, for the use of the waters of Reynolds Creek, a tributary of John Day River,

for the PURPOSE of Irrigation

that the PRIORITY OF THE RIGHT dates from September 14, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.0 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: 2400 feet South and 1550 feet East from the Northwest Corner of Section 25, being within the SE 1/4 NW 1/4 of Section 25, Township 13 South, Range 34 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 13 South, Range 34 East, WM Section 22 SE 1/4 SE 1/4 1.7 acres Section 23 NW 1/4 SW 1/4 3.8 acres SW 1/4 SW 1/4 20.2 acres SE 1/4 SW 1/4 0.2 acre Section 26 NE 1/4 NW 1/4 10.6 acres NW 1/4 NW 1/4 3.5 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre—feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **january 16, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 86.
