PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **66095** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **William G. Powell and Gail D. Powell of Route 1, Box 166B, Riddle, Oregon 97469, for the use of the waters of Cow Creek, a tributary of South Umpqua River,**

for the PURPOSE of **irrigation and stock watering, being 0.006 cfs for irrigation and 0.005 cfs for stock watering**

that the PRIORITY OF THE RIGHT dates from **September 15, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.011 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **80 feet North and 2170 feet East from the Southwest Corner of Section 19, being within the SE 1/4 SW 1/4 of Section 19, Township 30 South, Range 5 West, WM, in the County of Douglas.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

**Township 30 South, Range 5 West, WM Section 19 SE 1/4 SW 1/4 0.5 acre
Stock watering**

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/70 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **January 16, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19 **85**.

Complete application of the water to the proposed use shall be made on or before October 1, 19 **86**.
