PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **66885** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **Eldon Harrold of 83647 North Dale Kuni Road, Creswell, Oregon 97426, phone 895-4362** for the use of the waters of Hill Creek and wastewater reservoir, a tributary of Coast Fork Willamette, to be constructed under Application R-65488, Permit R-9200, for the PURPOSE of **irrigation**

that the PRIORITY OF THE RIGHT dates from **September 26, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.68 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 1550 feet South and 870 feet West, being within the SE 1/4 NE 1/4 of Section 12; Diversion 2 - 1355 feet South and 2990 feet West, being within the SE 1/4 NW 1/4 of Section 12, both from the Northeast Corner of Section 12, Township 19 South, Range 3 West, WM, in the County of Lane.**

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir to be constructed under Permit R-9200, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **January 30, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before **October 1, 1985**.

Complete application of the water to the proposed use shall be made on or before **October 1, 1986**.
