## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 66891 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Delbert and Donna Burril of Route 1, Box 641, John Day, Oregon 97845, phone 932-4752, for the use of the waters of an unnamed draw and John Day River, a tributary of Columbia River, being 0.03 cubic foot per second from the unnamed draw and 0.17 cfs from the\* for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from September 26, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.2 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 (Unnamed Dam) - 230 feet North and 80 feet West from the East 1/4 Corner of Section 26, being within the SE 1/4 NE 1/4 of Section 26, Township 13 South, Range 30 East; Diversion 2 (John Day River) - 1700 feet North and 650 feet East from the Southwest Corner of Section 20, being within the NW 1/4 SW 1/4 of Section 20, Township 13 South, Range 31 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* John Day River,

Township 13 South, Range 30 East, WM Section 26 SE 1/4 NE 1/4 Diversion 1 1.0 acre

SE 1/4 NE 1/4 7.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre (unnamed draw) and 5.0 acre-feet per acre (John Day River) for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **February 3, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985. Extended to Oct. 1, 1986

Complete application of the water to the proposed use shall be made on or before October 1, 1986 Extended to October 1987
