PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67098 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Tibor and Nancy Stefansky of Route 2, Box 700, Prairie City, Oregon, 97869, phone 820-3572, for the use of the waters of Bosonberg Creek, a tributary of Malheur River,

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from September 30, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.38 cubic feet per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 90 feet North and 1250 feet East from the Northwest Corner of Section 24, being within the SW 1/4 SW 1/4 of Section 13; Diversion 2 - 4980 feet South and 460 feet East from the Northwest Corner of Section 24, being within the SW 1/4 SW 1/4 of Section 24, both within Township 16 South, Range 33 1/2 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **February 10, 1985** reasonable diligence and be completed on or before October 1, 19 **85** .

Complete application of the water to the proposed use shall be made on or before October 1, 19 86 .
