## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67432 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Marilyn Smith of Route 1, Box 572, John Day, Oregon 97845, phone 932-4624, for the use of the waters of John Day River, a tributary of Columbia River,

for the PURPOSE of irrigation

that the PRIORITY OF THE RIGHT dates from October 7, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.45 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 390 feet South and 2110 feet East from the Northwest Corner of Section 25, being within the NE 1/4 NW 1/4 of Section 25; Diversion 2 - 810 feet South and 300 feet West from the Northeast Corner of Section 26, being within the NE 1/4 NE 1/4 of Section 26, both in Township 13 South, Range 30 East; Diversion 3 - 1700 feet North an 650 feet East from the Southwest Corner of Section 20, being within the NW 1/4 SW 1/4 of\*

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

\* Section 20, Township 13 South, Range 31 East, WM, in the County of Grant.

Township 13 South, Range 30 East, WM Section 25 NW 1/4 NW 1/4 15-2 acres SW 1/4 NW 1/4 0.6 acre Section 26 NE 1/4 NE 1/4 2.2 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before **February 15, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986
