PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67709 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Dave and JoAnn Tripp of PO Box 962, Mt. Vernon, Oregon 97865, phone 932-4483, for the use of the waters of Harper Creek when available with any deficiency in the available supply from Harper Creek to be made up by appropriation* for the PURPOSE of irrigation of 5.0 acres

that the PRIORITY OF THE RIGHT dates from October 13, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.13 cubic foot per second

The POINT OF DIVERSION is to be LOCATED: Diversion 1 - 2200 feet North and 200 feet West from the Southeast Corner of Section 29; Diversion 2 - 2300 feet North and 260 feet West from the Southeast Corner of 29, both being within the NE 1/4 SE 1/4 of Section 29, Township 13 South, Range 30 East, WM, in the County of Grant.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

* from John Day River, a tributary of Columbia River,

Township 13 South, Range 30 East, WM Section 29 NE 1/4 SE 1/4 5.0 acres

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/40 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 21, 1985, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985.

Complete application of the water to the proposed use shall be made on or before October 1, 1986.
