PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION **67774** and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to **John C. Miller and Joanne L. Miller of 8610 Sandstone Court, Roseville, California 95959, phone (503)479-4333, for the use of the waters of Dompier Creek, a tributary of South Umpqua River with any deficiency in the*** for the PURPOSE of **domestic use for one family including the irrigation of not to exceed one-half acre lawn and noncommercial garden**

that the PRIORITY OF THE RIGHT dates from **October 13, 1983**

and is limited to the amount of water which can be applied to beneficial use and shall not exceed **0.01 cubic foot per second**

The POINT OF DIVERSION is to be LOCATED: **Diversion 1 - 3160 feet North and 750 feet East, from the Southwest Corner of Section 23, being within the SW 1/4 NW 1/4; Diversion 2 - 2630 feet North and 1650 feet East, from the Southwest Corner of Section 23, being within the NE 1/4 SW 1/4; Diversion 3 - 4000 feet North and 1160 feet East, from the Southwest Corner of Section 23, being within the NW 1/4 NW 1/4, all of****

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

- * available supply from Dompier Creek to be made up by appropriation from a natural lake,
- ** Section 23, Township 30 South, Range 2 West, WM, in the County of Douglas.

Township 30 South, Range 2 West, WM Section 23 NE 1/4 SW 1/4 Domestic use for one family including the irrigation of not to exceed one-half acre lawn and noncommercial garden

Actual construction work shall begin on or before **February 21, 1985**, and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19⁸⁵.

Complete application of the water to the proposed use shall be made on or before October 1, 19⁸⁶.
