PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 67509 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following

This permit is issued to Rickey F. and Linda J. McMillan of 1169 Sable Drive, Roseburg, Oregon 97470, phone 673-1420, for the use of the waters of North Umpqua River, a tributary of Umpqua River,

for the PURPOSE of irrigation and domestic use for one family, being 0.013 cubic foot per second of water for irrigation of 1.0 acre and 0.005 cfs for domestic use

that the PRIORITY OF THE RIGHT dates from October 11, 1983

and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.018 cfs

The POINT OF DIVERSION is to be LOCATED: 470 feet South and 165 feet East from the N 1/4 Corner of Section 21, being within NW 1/4 NE 1/4, Section 21, Township 26 South. Range 5 West, WM, in the County of Douglas.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 26 South, Range 5 West, WM Section 21 NW 1/4 NE 1/4 Domestic use for one famliy NW 1/4 NE 1/4 1.0 acre Irrigation

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands shall be limited to 1/80 of one cubic foot per second per acre, and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 2, 1985 , and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1985

Complete application of the water to the proposed use shall be made on or before October 1, 1986
