APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, W F Hogue (Name of Applicant) of Grants Pass (Postoffice), County of Josephine State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

1. The source of the proposed appropriation is Skunk Creek (Name of stream)

tributary of Rogue River

2. The amount of water which the applicant intends to apply to beneficial use is 0.03 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located Commencing at the Southwest corner of Section 17, thence East 83 rods, thence North 3 rods. (Give distance and bearing to section corner)

being within the SE 1/4 SW 1/4 of Sec. 17, Tp. 36 S (Give smallest legal subdivision) (No. N. or S.)

miles in length, terminating in the SE 1/4 SW 1/4 of Sec. 17, Tp. 36 S (Smallest legal subdivision) (No. N. or S.)

NOTE: ATTENTION IS CALLED to Application No. 1868, Permit No. 906, in the name of the Chicago, Rogue River Canal Company, which covers the irrigation of land under this permit.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right herein granted is limited to the appropriation of water from Skunk Creek for irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.03 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is October 26, 1920

Actual construction work shall begin on or before November 5, 1921 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1922

Complete application of the water to the proposed use shall be made on or before

October, 1, 1923, WITNESS my hand this 5th day of November, 1920
